

ONE DAY TEAM TROPHY COMPETITION

- 1. Each Club can enter a team of five players, whose names, with current handicap indexes must be submitted by a designated date to the Competition Secretary.
- 2. Entries and entry fees to be received by date of the Council Meeting. A draw for the participating clubs to be made at that meeting by the Competition Secretary and the County Ladies' Vice-Captain.
- 3. The competition is 18 holes Stroke play with 95% allowance of course handicap.
- 4. The team shall play in Course Handicap order, lowest first. Failure to observe this rule will result in disqualification of the team.
- 5. Should a player be disqualified, for whatever reason, it will not disqualify the whole team.
- 6. If the weather conditions are extremely bad, the Captains of the Teams scheduled to play first, the organisers, and the host Captain, shall decide the availability of play.

7. Trophies

- The team returning the lowest aggregate of the best four gross scores will be awarded the Scratch Trophy for one year.
- The Team returning the lowest aggregate of the best four nett scores will be awarded the Handicap Trophy for one year.
 Should one team return the best gross and best nett, they shall hold the Gross Trophy, and the second lowest aggregate nett score will hold the Handicap Trophy.
- An Individual Plate will be awarded to the best individual gross.
- An Individual Plate will be awarded to the best individual nett score.

TERMS OF COMPETITION

CLCGA Competitions are run under the R & A Rules of Golf and any local rules of the hosting club.

Ladies and Girls must be members of the CLCGA and have a WHS handicap index.

Entry fees are at the discretion of the Executive Committee.

If a player is not on the first tee at her allocated time, R & A Rule 5.3a will be invoked.

In the event of a tie, the fifth player's card will be added as a decider. In the event of a further tie a card play-off (CPO) over the back 9, 6, 3, 1 holes, followed by the front 9.

Trophies will be presented on completion of the competition and awarded again at the Annual General Meeting, usually held in November.

If play is suspended the host club's adverse weather/suspension protocol will be followed.

Should a competition have to be abandoned due to adverse weather conditions, the trophy/trophies will not be presented, but prizes will be awarded on 9 holes provided that all the competitors have completed, or had the opportunity to complete, that number of holes (18 holes for the championships).

A ride-on buggy can only be used by competitors if permission is given by the CLCGA Competition Secretary at least two days before the event. The Competition Secretary may request evidence of a medical condition. The buggy must be arranged directly with the host club and paid for by the user. It can only be used to carry the player and that player's equipment. If a player uses her own buggy, she must provide a valid insurance certificate and adhere to the same conditions stated by the host club.

Caddies are permitted in the One Day Team Trophy, see R&A Rule 10.3.

The Executive Committee reserves the right to alter or amend the terms of a competition.

All disputes and matters arising in connection with a competition will in the first instance be referred to the Hon. County Competition Secretary. A player(s) may appeal to the Executive Committee, whose decision is final.
